- Course Description:

Objective : Social Policy is not only shaped by the political, social, economic and cultural background of a country, but also by international factors such as globalization. More and more globalization is forcing sovereign welfare states to react to increased economic competition and the “new social risks.” One of the unexpected benefits of this is that learning from the experiences and programs of other countries has been a major driving force for policy reform. As a result, this course will analyze how Taiwanese social welfare systems compare with other established overseas models.

An outline of this course is as follows. Beginning with a theoretical discussion of the driving forces behind the welfare development and welfare regimes concepts, students will be introduced to Taiwanese welfare development, followed by an overview of the concepts of social security, including an explanation of the agency, the coverage, financial models, and the benefits. A systematic analysis of Taiwanese social insurance (pension, health care, unemployment, work injury and maternity) will then be given which further encompasses social relief, anti-poverty and other institutional arrangements and practices. The latter part of this course includes an examination of the strengths and weaknesses of the social security system, as well as social services programs, especially long-term care systems. Throughout the course, attendees will consider the regime concept and comparative perspectives when analyzing all the topics mentioned.
